THIS IS CRITICAL, BECAUSE CEO PAYS EACH MEMBER OF A WORK CREW ON A DAILY BASIS, AND THIS DAILY INCOME CAN PAY FOR FOOD AND OTHER NECESSITIES. THE DAILY PAY SCHEDULE ELIMINATES THE INCOME TIMING GAP INHERENT IN BI-WEEKLY OR MONTHLY PAY CYCLES. SECOND, CEO ASSIGNS ONE SITE SUPERVISOR PER WORK CREW; EACH CREW HAS 5-7 PARTICIPANTS. THIS 1:5-7 RATIO ENABLES OUR SUPERVISORS TO CLOSELY GUIDE AND COACH EACH CREW MEMBER, REWARDING THE BEHAVIORS THAT EMPLOYERS SAY THEY VALUE MOST: ARRIVING ON TIME, FOLLOWING DIRECTIONS FROM A SUPERVISOR, WORKING HARD, AND USING GOOD COMMUNICATION SKILLS. THE WORK CREW MODEL EMPHASIZES PROGRESS AND MOMENTUM; CLIENTS SUPPORT ONE ANOTHER AND GAIN MOTIVATION FROM EACH OTHER'S SUCCESSES.

## VOCATIONAL TRAINING:

PARTICIPANTS STAY ON TRANSITIONAL WORK CREWS FOR AN AVERAGE OF TWO TO THREE MONTHS, BUT EACH INDIVIDUAL MOVES THROUGH THE PROGRAM AT HIS OR HER OWN PACE. PARTICIPANTS WORK ON A CREW FOR UP TO FOUR DAYS PER WEEK AND DEDICATE ONE ADDITIONAL DAY TO MEETING WITH CEO'S VOCATIONAL SUPPORT STAFF, WHO ARE JOB COACHES AND BUSINESS ACCOUNT MANAGERS. BEHAVIORS, AND HELP THEM DEAL WITH ANY ISSUES THAT MAY ARISE DURING THEIR WORK CREW EXPERIENCE. AFTER A PARTICIPANT SHOWS CONSISTENT, HIGH PERFORMING WORKPLACE BEHAVIORS, JOB COACHES DEEM THE PARTICIPANT "JOB START READY" AND ASSIGN THEM TO A BUSINESS ACCOUNT MANAGER (BAM). BAMS WORK DIRECTLY WITH EMPLOYERS IN THE LOCAL ECONOMY TO IDENTIFY LABOR MARKET NEEDS AND POTENTIAL JOB OPPORTUNITIES. BAMS THEN MATCH ELIGIBLE PARTICIPANTS WITH THESE EMPLOYERS, AND SCHEDULE INTERVIEWS FOR THE PARTICIPANTS WHO ARE SUCCESSFUL IN OBTAINING EMPLOYMENT.

SINCE BECOMING AN INDEPENDENT NONPROFIT ORGANIZATION IN 1996, CEO HAS CREATED THOUSANDS OF TRANSITIONAL JOB OPPORTUNITIES THAT HAVE LED TO OVER 25,000 FULL-TIME JOB PLACEMENTS FOR FORMERLY INCARCERATED PERSONS. IN FY16, CEO EMPLOYMENT SERVICES RESULTED IN MORE THAN 2,715 FULL-TIME JOB PLACEMENTS IN INDUSTRIES AND SECTORS AS DIVERSE AS FOOD SERVICE, RETAIL, WHOLESALE, MANUFACTURING, HUMAN SERVICES, CONSTRUCTION, MAINTENANCE, AND WAREHOUSING.

ONCE A PARTICIPANT IS PLACED IN A NON-SUBSIDIZED JOB, HE/SHE BEGINS WORKING WITH A CEO RETENTION SPECIALIST. RETENTION SPECIALISTS WORK WITH EACH PARTICIPANT TO HELP THAT INDIVIDUAL REMAIN CONNECTED TO THE WORKFORCE. RETENTION SPECIALISTS OFFER WORKPLACE COUNSELING, CRISIS MANAGEMENT, NEW JOB DEVELOPMENT IN THE EVENT OF A JOB LOSS, AND LONG-TERM CAREER PLANNING FOR ONE YEAR AFTER PLACEMENT. AN INCENTIVE-BASED JOB RETENTION PROGRAM ALSO HELPS REWARD PARTICIPANTS THE LONGER THEY REMAIN EMPLOYED
