ONCE A PARTICIPANT IS PLACED IN A NON-SUBSIDIZED JOB, HE/SHE BEGINS WORKING WITH A CEO RETENTION SPECIALIST. RETENTION SPECIALISTS WORK WITH EACH PARTICIPANT TO HELP THAT INDIVIDUAL REMAIN CONNECTED TO THE WORKFORCE. RETENTION SPECIALISTS OFFER WORKPLACE COUNSELING, CRISIS MANAGEMENT, NEW JOB DEVELOPMENT IN THE EVENT OF A JOB LOSS, AND LONG-TERM CAREER PLANNING FOR ONE YEAR AFTER PLACEMENT. AN INCENTIVE-BASED JOB RETENTION PROGRAM ALSO HELPS REWARD PARTICIPANTS THE LONGER THEY REMAIN EMPLOYED DURING THAT FIRST YEAR.

OF PARTICIPANTS PLACED IN FULL-TIME JOBS IN THE PRIOR FISCAL YEAR, 57.5% WERE STILL WORKING AT THE 180 DAY MILESTONE, AND 47.5% WERE WORKING AFTER 365 DAYS. CEO USES RIGOROUS VERIFICATION METHODS TO DETERMINE JOB RETENTION: PAY STUBS, CRIMINAL JUSTICE OFFICIAL SIGNATURES, AND/OR INDEPENDENT EMPLOYER VERIFICATION.
